37/22 MINUTES OF THE LAST MEETING

The minutes of the meeting held on 26 April 2022 were approved as a correct record.

38/22 ACTION LOG

11/21 – Universities Wales letter of invitation – The Director of Partnerships and Engagement agreed to update members as part of the update at agenda item 5. The action was closed.

07/22 – Trust Priorities aligned with the ITMP - The priorities are mapped to the IMTP with the Finance and Performance Committee monitoring these, with exception reporting to this Committee if needed. The action was closed.

RESOLVED: That

- 1) 11/21 would be discussed as part of the agenda; and
- 2) 07/22 action was complete and could be closed.

39/22 DIRECTOR OF PARTNERSHIPS AND ENGAGEMENT UPDATE

The Director of Partnerships and Engagement began by updating members on the correspondence with Ben Arnold from Universities Wales and that a response was still awaited to allow the Committee to move forward with engaging an all Wales university representative.

At a recent event, it was recognised that a Health Board with a similar Academic Partnership Committee had secured multiple Higher Education partners and managed any potential conflicts of interest with strong governance.

It was suggested that the Chair, Director of Partnerships and Engagement, the Board Secretary, the Head of Education and Head of Risk/Deputy Board Secretary meet to discuss how best to approach universities and develop the relationships.. Members were keen to secure volunteers who would be willing to work with the Trust and look at the opportunities available.

The Director of Partnerships and Engagement continued to apprise members on the progress to date of mapping the engagement interfaces across the Trust, in order to review where relationships already existed. It was agreed that the full mapping exercise would be considered at the next meeting.

Members discussed and agreed that a primary Welsh University representative would be key to the Committee however also it was also agreed that to ensure best fit, innovation and relationship building, a national representative for niche areas could be considered.

The Director of Partnerships and Engagement had attended a recent University and Designation Showcase event involving all health organisations across Wales. Of those

organisations who already held university status, it would be a requirement from this year for them to provide a mid year review of their priorities in relation to activity and outcomes. This would be in addition to the routine IMTP monitoring reports that were also required. The Trust was also required to provide an update on its priorities as set out within the application for university status. It was anticipated that the report would need to be submitted early October to cover the April to September period.

The Head of Education reiterated the focus needed to be on improving the service through innovation, research, training and education.

Following a discussion on qualifications issued by institutions and the need to explore opportunities for innovation and improvement and connection with high quality, action research which can be applied in practice. The Chair asked the TU Partners to relay to colleagues the opportunities that university status/partnerships would bring to ensure that all staff felt included regardless of their academic status or ambition.

RESOLVED: That

- 1) a small group meet to discuss the way forward in approaching universities;
- 2) the full mapping of engagement interfaces be brought to the next meeting; and
- 3) a mid year review of priorities in relation to activity and outcome be presented to the Trust Board in September.

40/22 PRIORITY ONE: DIGITISATION ENABLING BETTER OUTCOMES: DIGITAL OPPORTUNITIES

The Assistant Director of Digital set out the ambition to build on the work already ongoing within the Trust with regard to digital opportunities in partnership with academia.

The Assistant Director presented to the Committee on what successful partnerships look like and where potential opportunities may lie. The presentation included the Great Ormond Street Innovation Accelerator Data, Research, Innovation and Virtual Environments Unit (DRIVE) which was a data management platform. The innovation element involved staff across different sectors being able to turn ideas into implementation.

The University College London Industry Exchange Network was another example which saw students engage with industry as part of their computer science degrees.

With regard to opportunities, the Director confirmed that in order to engage with partners, problem areas first needed to be identified to look at the fields such as accessibility, efficiency, quality and equity for future engagement, aligning it with the Trust's strategy and aims. With these areas the potential digital interests such as speech recognition and artificial intelligence could be explored further.

There were a number of organisations who were keen to, or had previously collaborated with the Trust from a digital angle. The potential forms of collaboration were in education and training, research and innovation and industry/academic partnerships to problem solve.

The Assistant Director noted that the areas that the Trust would be seeking partnership with, could be pitched to academia who would welcome the opportunity to work with the Trust to provide solutions. It was noted that currently the Trust did not have the capacity to support

innovation streams.

Members welcomed the presentation and asked the Director of Partnerships and Engagement to contact a member of the WIIN team to liaise with Great Ormond Street team to look at what could be learnt. Members also requested that digital opportunities be highlighted across the Trust with a potential session for Board members at a development day.

- 1) the Director of Partnerships and Engagement ask a member of the WIIN team to contact Great Ormond Street and look at opportunities for learning; and
- 2) the Interim Director of Digital liaise with the Board Secretary on holding a Board Development session to explore digital partnership opportunities.

SITUATION

6. The purpose of this paper is to provide the Committee with a draft cycle of business as the final step in the 2021/22 effectiveness review process.

BACKGROUND

- 7. The Board carried out its effectiveness review in Quarters 4 2021/22. This included a review of its terms of reference, amendments to which were approved by the Trust Board in May 2022.
- 8. The final step in the effectiveness review process is the development a cycle of business for the Committee and a review of its sub-committee structure.

ASSESSMENT

Cycle of Business

- 9. A cycle of business provides order and structure and sets a Committee work plan for the year. This, together with the Board Assurance Framework, should drive agenda setting. It also:
 - 9.1. allows papers to be planned in advance, giving Directors and report writers the opportunity to plan necessary pre-committee forums and align cycles of business;
 - 9.2. schedules compliance related reports according to legislative or regulatory timeframes;
 - 9.3. provides focus for reporting and an opportunity to see where there may be duplication, gaps, and interrelationships;
 - 9.4. generates commitment to review matters that may sometimes be vulnerable to postponement;
 - 9.5. allows for easy tracking of the Committee's adherence to the cycle which is a marker of an effective Committee;
 - 9.6. provides for a collective awareness and agreement of the areas where it applies its focus on an annual basis; and
 - 9.7. removes the ad hoc elements of agenda setting.
- 10. Whilst it is inevitable that other items will arise from time to time, the cycle allows them to be prioritised perhaps coming later on the agenda.
- 11. The cycle of business at **Annex 1** includes further detail on the pre-committee forums, lead presenters, purpose of reports and any relevant and/or helpful commentary. There is also a notes tab for running commentary helpful for the

- Committee. The cycle includes each of the duties for the Committee in the terms of reference (in red text) so members can see and demonstrate that the reporting expected for each area will in fact provide appropriate assurance, generate discussion, and allow for the right balance of challenge and support.
- 12. The cycle for the Committee is a maturing document which will grow organically over the next 12 months. Our Ambition



- To deliver better services for the people of Wales, and secure greater opportunity for our people, by leveraging our educational, training, innovation and industry relationships in a more integrated way

Progress Against Objectives











Priority One: Digitisation











Deployment of our digitised patient record system (ePCR) & Digital Triage System ECNS



- ePCR system now deployed resulting in reduced reliance on paper records and improved capability to share secure information with other healthcare providers
- Some elements being finalised, including interface with the Welsh GP Records system to access medication and allergies information
- Ready for testing on pilot Android devices to extend to CFRs
- ECNS implemented (Including Video Function), removing paper triage in 999. Further work to interface with ePCR and Welsh GP Records.









Improved access to integrated intelligent information

- Exploring data linkage with DHCW to integrate ED and CAD data, supplemented by ePCR & ECNS data, to better understand success of pathways and patient outcomes
- Progressing work under the National Data Resource programme (led by DHCW)
 which will create a central data store for all NHS Wales, allowing an array of data
 linkage opportunities and improved visibility of patient flow and outcomes
- New data derived via implementation of Emergency Communication Nurse System (ECNS) provides new research opportunities, with three proposals currently going through IRAS application/ethics stages
- Working with Health Technology Wales to explore possible further research opportunities afforded by implementation of digital technologies (Topic Exploration Reports)









Explore development and deployment of artificial intelligence and machine learning to reduce clinical risk, and improve optimisation of operations



- Several processes from various Directorates have been mapped and are being automated using Robotic Process Automation (RPA) technology e.g. falls referral pathway.
- RPA was also deployed used in support of BCI across the 111 service following cyber attack on Advanced services.
- RPA reduces administrative burden, and can significantly increase efficiency, improve standardisation, and allow clinical, operational, and corporate experts to instead spend their time on higher value tasks.
- More work underway to identify the opportunity and evaluate impact









Introduction of video triage in the remote clinical assessment environment (999 Clinical Support Desk)



- Implementation of video consultation allowing clinicians to call patients directly and supporting remote resolution of incidents without the need of an automatic face-to-face assessment
- Internal collaboration and expert advice has meant "Privacy by Design" requirements are met, and the internal standard operating procedure (SOP) is compliant with data protection and privacy standards
- Research study currently going through IRAS approval process in respect of use of video – partnership between WAST & International Academies of Emergency Dispatch.

Priority Three: Decarbonisation, fleet modernisation and sustainability











A tripartite research and development programme between WAST, Toyota GB and Wilker UK has delivered 23 Toyota RAV4 plug-in hybrid rapid response cars, replacing some of the Trust's older diesel-powered vehicles. This new design includes:

- Plug in hybrid infrastructure allowing journeys of up to 45 miles to be completed via electrical charge
- A reconfiguration of the rapid response car and its contents which has reduced the overall weight by almost 100kg, meaning a significant increase in the miles per gallon and therefore reduction in emissions
- Every vehicle has been fitted with solar panels on its roof, generating renewable energy to support internal electrical infrastructure for clinical equipment











Major decarbonisation projects at AAC Flintshire (Dobshill), Porthcawl, Lampeter and Bargoed Ambulance stations completed in 2022. Aim is to reduce carbon emissions and provide a fit for purpose wellbeing area on site at Flintshire ACC.

- Projects included installation of PV arrays & battery storage, plus replacement high carbon emission heating systems for an air source heat pump. WAST worked in conjunction with Solar Edge UK, to develop bespoke renewal energy designs, all supported by WGES
- Redevelopment of two hectares of land included the planting of 2500 British native trees, with additional biodiversity and ecology features, working in conjunction with North Wales Wildlife Trust

Future projects, aimed at supporting a net zero carbon estate approach:

- SPECIFIC innovations and Knowledge Centre at the University of Swansea have supported, and continue to support our new build decarbonisation objectives.
- Retrofit decarbonisation design guide specifically for WAST estate is being developed in conjunction with the Centre of Alternative Technology and the University of East London (postgraduate student)











And there's more . .

- Work underway with Fujifilm on a domiciliary x-ray project funded by the Bevan Commission.
- Work underway with SME (Science and engineering applications ltd.) on a digital platform to facilitate our inverting the triangle delivery (Welsh Health Hack funding stream); possible marketing strategy affiliates to include BT/EE and Tesco et al.
- Evaluation of mobile point of care assay solutions beginning this month with clear links to industry.
- Strong track record of collaboration with industry (eg DRONES Artificial Intelligence) in the innovation space
- Robust portfolio of research studies and grant applications across directorates and workstreams









Learning to-date

- Prospect of achieving UTS has galvanised us to rethink our approach to "three pillars work" discussion at Executive and Committee level about how to better integrate innovation, research and training/education to avoid silos and better align portfolios
- Ensuring we are a broad church representation at APC by TU partners, Committee taking a learning/exploratory approach, reporting through to Board, "effectiveness review" undertaken to continue to improve committee working, avoid duplication etc
- Mapping our interfaces understanding where our opportunities and "gaps" are –
 where we are engaged and where we need to be reporting to committee this month
- More to do on engaging the wider workforce and taking people on the journey this will be a focus in 2023

- 1. The ambition of the Welsh Ambulance Service in respect of its academic and industrial relationships is to ensure they are leveraged to make a tangible difference to our people and our patients.
- 2. As the Trust moves closer to attaining university trust status and to furthering its long term plan, there is a need to identify where and how the organisation interfaces with its academic and industry stakeholders.
- 3. Given that colleagues from a range of portfolios have relationships with a range of academic and industry partners, it is important that the wider organisation, via the Academic Partnerships Committee in the first instance, both understands those interfaces and also is able to identify opportunities and gaps.

KEY ISSUES/IMPLICATIONS

4.

- Interfaces across the organisation are extensive albeit somewhat fragmented
- As an organisation, much of this work is not visible at Board level. This is something which requires attention, both to celebrate achievement but also to understand the tangible difference that these relationships are delivering
- There is appetite and expertise to work with industrial and academic partners, and considerable opportunity to work more extensively, and in a more integrated way, with partners
- There is a great deal of scope to more clearly link the excellent work being undertaken in a variety of directorates with organisational direction and to evaluate the impact of the initiatives in train
- 5. This paper is for discussion. Any actions arising will be taken forward via the Executive Management Team and reported back to Committee in due course.

- 9. Via the Executive Management Team, a request for information relating to academic and industrial interfaces within directorates was made.
- 10. The responses received are detailed below. It is unclear how comprehensive this information is, but what it does demonstrate is that, while there is a significant amount of academic and commercial/industrial engagement underway, there is significant opportunity to harness these opportunities in a more strategic way.

11. Among the observations are:

- it is unclear as to what extent there is interface between directorates where there might be further opportunity to exploit existing or new partnerships. This is something for discussion, both at committee and within the Executive Team
- there are clear opportunities to further align engagement with both longer term and IMTP priorities, and to better capture outputs
- There is appetite and expertise to work with industrial and academic partners, and considerable opportunity to work more extensively, and in a more integrated way, with partners
